The Annual Meeting was called to order at 6:00 p.m. by President Mignon Tucker. A quorum was confirmed, notice was properly given, and last year's minutes were approved.

The President reviewed 2024 projects and budget items, noting insurance costs rose 20% to \$88,000, with potential for further increases. She reported on pool operations, landscaping, maintenance, pest control, chimney inspections, and gutter cleaning. The Comcast contract will end in July 2026, saving over \$60,000 annually which will be added to reserves.

Owner questions addressed insurance, legal fees tied to boundary issues, budget surplus (\$167,000), and roof replacements (50 completed, 11 failures). The timely special assessment funded these costs. A dues increase of 4.5% to \$365/month beginning January 2025 was recommended per the reserve study.

The Treasurer's report (delivered by the President) thanked owners for approving the \$12,000 annual special assessment, which enabled roof projects. Roof sheathing has been upgraded to code with fireproof materials, and MRI confirmed quality. The association is financially sound, with reserves covering upcoming expenses. Projects planned include a new pool gate and exploring additional fencing due to west-side development.

Attorney Miles Dumville reported on blasting planned for the Greystar project; residents should document current conditions. Owner comments also covered communication needs, the 2025 budget (to be presented in November), development impacts, and dog waste compliance.

Board elections were held: all current members were re-elected except Treasurer Charles Crenshaw, replaced by Liz Tyson. The meeting adjourned at 7:40 p.m. The new board then convened, re-electing all officers with Tyson as Treasurer. Adjournment followed at 8:00 p.m.

CONFLICT OF INTEREST AMENDMENT to ARTICLE IV, PARAGRAPH G OF THE HUNTINGTON VILLAGE BY-LAWS

Proposed Revision to Article IV, Paragraph G – Conflicts of Interest

No member of the Board of Directors shall participate in any pending decision of

the Board, whether by voting or by attempting to influence the voting on such decision, where such individual has a financial conflict of interest. A financial conflict of interest arises when (i) a director; (ii) a family member; (iii) an entity for which the director or a family member serves as an officer, director, employee,

or agent, or (iv) an entity in which the director or a family member owns an interest or controls, would financially benefit from the contract,

transaction, or other arrangement with the Association that is the subject of the pending decision. A conflict of interest shall not be deemed to exist where such financial benefit is no greater

than that conferred on all unit owners generally such as, for example, where improvements are made to the common areas.

For purposes of this provision, the term "family member" means an individual related to the director by blood, marriage, or adoption. With regard to publicly traded entities, a director shall not be deemed to own an interest in such entity if

the director and/or family members collectively control less than ten percent (10%) of the voting power of all owners of an interest in the entity.

Any such financial conflict of interest, whether actual or perceived, must be disclosed in writing to the full Board immediately upon identification.

Directors found to be in violation of this policy shall be subject to immediate removal by vote of the majority of the remaining disinterested directors.

The intent of this provision is to avoid even the appearance of impropriety, ensure impartial governance and maintain the trust of the unit owners.
